**Your annual dues amount also includes membership to the North Carolina Home Builders (NCHBA) and the National Association of Home Builders (NAHB)**



2024 Annual dues include a payment for the state (NCHBA- \$70), (National (NAHB- \$198) as well as local (HCVHBA - \$282) Dues paid are not tax deductible as charitable contributions for income tax purposes. However, they may be tax deductible as ordinary and necessary business expenses subject to restrictions imposed as a result of the association lobbying activities. The NCHBA estimates the non-deductible portion of your 2024 due, the portion of which is allocable to lobbying is \$23.10 and is non-deductible but \$46.90 may be deductible as an ordinary and necessary business expense. NAHB has made a similar calculation. NAHB has determined that \$31.68 of their regular annual dues is non-deductible but \$166.32 may be deductible. The Home Builders Assoc. of Hickory - Catawba Valley, Inc. estimates the non-deductible portion of your 2024 local dues is \$14.10 and the remainder \$267.90 may be deductible.
