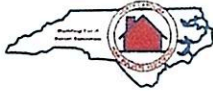

Your annual dues amount also includes membership dues to the **North Carolina Association of Home Builders (NCHBA)** and the **National Association of Home Builders (NAHB)**

*2021 Annual (Associate) membership renewal. Dues include payment for state (NCHBA-\$70), national (NAHB-\$198) as well as local (HCVHBA-\$282). Dues paid are not tax deductible as charitable contributions for income tax purposes. However, they may be tax deductible as ordinary and necessary business expenses subject to restrictions imposed as a result of association lobbying activities. The NCHBA (state) estimates the non-deductible portion of your 2021 dues-the portion which is allocable to lobbying-is 46% or \$32.20 and is not deductible but \$37.80 may be deductible as an ordinary and necessary business expense. NAHB (national) has made a similar calculation. NAHB has determined that 18% or \$35.64 of their regular annual dues is non-deductible but \$162.36 may be deductible. The HCVHBA (local) estimates the non-deductible portion of your 2021 local dues is 5% or \$14.10 and the remainder, \$267.90 may be deductible.*
